23/09/14 Five Year Plan

N Mr. Johnson The Chief staff and the Board discussed the five-year plan. Larry Bauer asked about the plan to rotate equipment. Service, cost of ownership, and cost to maintain was brought up to talk about when weighing in the options to rotate equipment. Ideally, the Board would like to see a more refined list as far as replacement of equipment/apparatuses. Larry Maloney wanted to see a relative cost. He also mentioned he'd like to see the research into the needs of the District brought up in the timeline to year 1 versus year 5. Jerry Hageman noted and brought up that the five-year plan doesn't showcase anything for the volunteer side. Per Jerry, recruitment and retention needs to be one of our top priorities. He also discussed that there are no true benchmarks in the plan and would like to see actual dates.

23/09/15 Light Duty Policy - #207

Mr. Johnson Larry Maloney asked about the maximum of 12 months of medical leave while being on light duty status. He brought up maybe shortening the time frame of 12 months, but Deputy Chief Snider's response was that based on his research, most departments across the country have their light duty policies set up with a 12-month maximum. Jerry Hageman asked about the pay of those on light duty, in which Deputy Chief Snider responded the individuals pay would be reduced to an 80 hour pay period at their same hourly rate. Jerry Hageman and Deputy Chief Moore discussed how overtime and training would be approved while an individual would be on light duty. The policy says that a person on light duty is not permitted to train but still needs to maintain their certifications/licenses that they carry. Tommy Johnson motioned to approve the adoption of Policy 207 – Light Duty; Larry Bauer seconded the motion. Larry Maloney and Larry Bauer were both in favor, Jerry Hageman was opposed.
